- Evacuate if told by your ERT Member or if announced over the P.A. system

IN THE EVENT THAT THE P.A. SYSTEM CALLS FOR AN EVACUATION:

- Immediately leave the building following the emergency exit plans for your facility location & assemble in the marked area
- Remain in this area until the emergency is over and your ERT member tells you that it is safe to re-enter the facility

1) PROTECTIVE CLOTHING AND EQUIPMENT

- a) **Eye Protection** - Safety glasses, as a minimum. Special eye protection and/or face protection will be worn when applicable.
- b) **Fall Protection** - Will be used when working around open holes, open pits or trenches where you could fall more than four (4) feet. When working over machinery where you could fall more than six (6) feet. Working from a scaffold that does not have a top rail, mid rail and toe board and when working from a powered or manual work platform.
- c) **Respiratory Protection** - Respirators or breathing apparatus must be worn on all jobs and in all areas in which there is a danger of overexposure to toxic or harmful fumes, mists, dusts, or vapors or in which there is an oxygen deficiency.
- d) **Protective Clothing** - Such as suits, aprons, boots, or gloves, shall be worn where there is a hazard to the body through contact with chemicals, dusts, heat or other harmful agents or conditions.

2) CONFINED SPACE ENTRY

Prior to any entry into a confined space (tank, vat, pit, sewer, etc.) a Confined Space Entry Permit must be in place.

3) CUTTING AND WELDING

Prior to performing any welding or cutting operation outside of a welding booth, a Cutting and Welding Permit must be obtained through the Process Equipment Company Safety Director.

4) LOCKOUT/LINE BREAKING

No work will be performed on electrical circuits, machinery or lines carrying hazardous liquids or gases under pressure until controlling switches and valves have been identified and positively locked out and appropriately tagged.

5) USE OF PROCESS EQUIPMENT COMPANY MATERIAL AND EQUIPMENT

Under no circumstance will Process Equipment Company tools, equipment or material be used by contractor personnel unless previous arrangements have been made.

6) USE OF HAZARDOUS MATERIALS

Contractor personnel shall bring no hazardous chemical onto the premises until and unless manufacturer Material Safety Data Sheets for the substance have been furnished to the Safety Director and specific approval obtained

7) REMOVAL OF MATERIALS

Contractors are responsible for removing their materials off site; i.e., chemicals, paint, solvents, etc.

8) SPILL/RELEASE REPORTING

Contractors are responsible for reporting any potential for environmental releases to the Process Equipment Company Safety Director. Contractors are responsible for reporting any spills to the Safety Director or a member of the ERT (Emergency Response/Spill) Team.
